**ANNUAL REGISTRATION FEE FOR 2009-2010**

Dear Colleague,

1. In accordance with Chapter VIII, Article XXII, § 1 of the WOSM Constitution and By-Laws, which states that *"Each Member Organization shall pay an annual registration fee..."*, I am sending you **enclosed** our official invoice for the amount due by your Organization as its registration fee for the year starting 1 October 2009, as well as, if applicable, the amount due by your Organization in registration fee arrears. To comply with the fee system, this invoice is established **in Swiss francs**.
2. This fee has been calculated in accordance with the provisions of Resolution N° 2/2008 "Registration fee system" adopted by the 38th World Scout Conference in Jeju, Korea in July 2008, which states :  
*"The Conference decides to adopt, as an interim situation for the tiennium 2008-2011, the alternative proposal contained in annex 4 of Conference Document 10, which renews the fees due during the triennium 2005-2008 adjusted for inflation by 4.3%."*

3. May I remind you that :
  - the annual fee **is due** at the beginning of every new fiscal year, i.e. on 1 October or at the closest dispatch date, and not at the end of this fiscal year;
  - the invoice is to be paid upon receipt;
  - for those NSOs wishing to do so, **payment can be made by instalments;**
  - the bank data are to be found **on the bottom of the invoice and on page 2 of this circular.**
4. In accordance with the "Policy concerning payment of Registration fees", Member Organizations who pay in full their registration fees within **60 days** of invoice date, i.e. until **26 December 2009**, may claim a discount of **2%**.

You may also decide to pay your registration fees in full and, provided your payment reaches us within the 60 day delay, ask the Bureau to credit the 2% discount to which you would be entitled to a provision account which will be used by the World Scout Committee to assist other National Scout Organizations which may face difficulties in the payment of their annual fees.

I stress the necessity for prompt and full payment of the annual fee invoice, so that the World Scout Bureau can continue to serve the Movement as effectively as possible, as it has always endeavoured to do, and can efficiently respond to the expectations of National Scout Organizations expressed during the 2008 Korea World Scout Conference
