1st International Seminar on Intellectual Property

Dear Colleagues:

We are happy to inform you that the National Scout Organization of Thailand (NSOT) will host the 1st International Seminar on Intellectual Property from 1st to 4th September 2009, organized jointly by the World Scout Bureau/ Central Office - Geneva together with Asia- Pacific Regional Office. Details of this seminar are as follows:

Aim: To bring greater awareness on the importance of the legal protection of Intellectual Property for Scouting. In particular, protection of trademarks (name, logos and emblems) and copyright material (such as publications and photos).

Objectives:

1. To provide information on what is Intellectual Property (IP)
2. Discuss the steps in protecting IP and its advantages
3. Share information on International IP Law
4. Share best practices in Scouting on IP

Venue: Bangkok, Thailand

Dates: 1st - 4th September 2009, arrival on 31st August and departure on 5th September 2009.

Fees: The fee is US\$100.00, which will cover inland transportation food, accommodation, seminar documents and educational tour.

Participants: This workshop is proposed to gather a maximum of 50 national and sub-national level leaders who are involved in the management of the organization. Leaders connected to Scout supplies, literature, organization policy and procedures.

Seminar staff: The course staff will be composed of experienced Scout Leaders from across the world and from the host country. Non Scout Resource persons may be invited to handle special topics.

Weather: Normal temperature during this month ranges from 25°C to 32°C.

What to bring: Set of Scout uniform, personal kit and light cotton clothing is advisable.

Course Contents: An overview of the need to manage and protect the Scout name, outline of the troubles that could arise, intellectual property within Scouting, IP owned by WOSM, rights of NSOs to use WOSM IP, advantages and disadvantages of IP protection, steps in protecting IP, use of IP as revenue stream.

Looking forward to receiving your nomination using the attached Reply Slip latest by **31st May 2009**.
